RULES FOR TOURNAMENT

1. Entry fee is \$25.00 per bowler (\$6.00 bowling, \$16.00 prize fund, \$3.00 expenses). Prize fund will be returned 100% at a ratio of at least 1:5. Expenses paid by Mason/Dixon 600 Club.
2. Format is three games on one pair of lanes. All lanes will be assigned, not drawn.
3. This tournament is sanctioned by the USBC. All USBC rules will be followed. Any decisions to be made during the tournament will be decided by the officers of the Mason/Dixon 600 Club.
4. Each entrant is required to be a current (2023-2024) member of the USBC and their local 600 Club.
5. Prizes will be awarded in both Scratch and Handicap divisions. Handicap will be 85% of the difference between the entering average and 220. Entering average is the highest final USBC-sanctioned average for the 2022 - 2023 season. If no average for 2022 - 2023 exists, entrant must use their highest average of 21 games or more as of November 1, 2023. If no 21 game average exists, entrant must use a 220 average. Rule 319a.2 (10-pin rule) will not apply. Rule 319a.3 will apply to all entries (average used). All winner's averages will be verified. Rules 319d (reporting of prize winnings) and 319e (average adjustment) will not apply.
6. Prize lists and checks will be distributed by the Mason/Dixon 600 Club within 30 days of the end of the tournament. Prize fund will be returned 100%.
7. Walk-ins are permitted if lanes are still available. Check-in time is 30 minutes prior to squad time. Any bowlers arriving late will start in frame currently being bowled and will receive a zero for any frames missed.
